They access the platform only through teacher-issued class codes, with no accounts or emails required. The system is also designed so that no student-identifiable activity is tracked. Describe the technical and physical measures in place to protect the PI.</i>	<ul style="list-style-type: none"> • PI is encrypted in transit and at rest; only authorized staff can access it; strong-password requirements are enforced. • Student accounts require no PI; adult PI is minimized and processed only as needed; secure third-party providers (e.g., hosting, payment processors) handle infrastructure and payments under strict contractual controls. • PI is retained only as long as necessary and deleted/anonymized afterward. • Hosting providers (Pagely, DigitalOcean) maintain secure data centers with environmental and physical protections, while monitoring tools (New Relic, Sentry) ensure system health without tracking student PI.

The service is hosted in the United States, and data may be transferred internationally for processing and storage. The privacy policy explicitly states that PI is stored and processed in the U.S. and may be transferred to other jurisdictions where third-party service providers operate.</p>

(Musicplay) under its Terms of Service and Privacy Policy; no PI is collected or owned for students (under 18) because student access uses class codes only. • PI is retained only as long as necessary for service delivery or legal purposes; when no longer needed, it is deleted or anonymized. Any PI captured in system backups is securely stored, isolated from further processing, and deleted when feasible. • Upon account deletion or user request, PI is removed from active systems; processors may only handle PI under Musicplay's instructions. Users can access, update, or request deletion of their PI at any time.
